

Annual Report of the Vicar

Dear friends in Christ,

When we began our life together in 2020, we knew that there was change ahead. We had a new place of worship, with one of our services creating a return to public Sunday worship on the campus of the Holderness School. We knew that we were on the path to become a canonically recognized single congregation, making "official" the reality that we had been living as "Holy Spirit & St. Mark's," one congregation of Episcopalians living, and worshipping, and serving in the Pemi-Baker Valley.

That roadmap took us as far as March 15, 2020, the 3rd Sunday in Lent, when in-person public worship paused for the Episcopal Church in New Hampshire. There was a new virus abroad in the world, and, from the start, the response of the Episcopal Church, and the Diocese of New Hampshire, and our own faith community, was to act in love. Practically speaking, the way to love our neighbors was to do all that we could to avoid the chance of spreading the virus person-to-person. And the common practices that made that possible were staying home as much as possible, and not gathering in-person in groups.

It's sobering now, to re-read the messages that expressed the hope, revised again and again, that we might re-gather on this date or that. It is nearly a year later, and the normal practice is still staying home as much as possible, and not gathering in-person in groups, for worship or other activities.

And in the midst of loss, suffering, illness, anxiety, and mourning: We are still finding ways to be church: "Church" generally, in the sense of undertaking the mission of the church as the catechism sets it out: "The mission of the Church is to restore all people to unity with God and each other in Christ" (BCP 855). And we found ways to keep becoming who we are: Emmanuel Episcopal Church, proclaiming in our very name our deep faith that "God is with us."

For this annual report on a year like no other, I want to highlight three practices that have brought us and kept us this far together: Worship, Communication, and Leadership.

Worship: From our first efforts to "be together though apart," by lighting a candle at home at the very moment the holy fire would have been lit at our Easter Vigil, all the

way through to our experiences of hybrid and extended worship this fall and winter, we have not stopped worshipping. Can it "feel like church" when we join remotely with Bishop Rob and our fellow NH Episcopalians for diocesan worship over Zoom? Can it "feel like church" when some of us gather outdoors in lawn chairs, safely distant from each other, while others watch or listen in as the service is broadcast over Zoom? Can it "feel like church" when everyone is praying on Thursday morning, not side by side in the same building, but connecting from our homes? Can it "feel like church" when home communion visits with clergy take place on a porch, in a driveway, in a backyard, in a barn? Can it "feel like church" when a service of Holy Eucharist is extended from one moment at the altar of the Chapel of the Holy Cross into many places and different times, with the elements blessed at a Sunday morning service distributed and then reverently received in our homes? Can it "feel like church" when readings, and hymns, and prayers are pre-recorded?

We have, to one degree or another, experienced these practices over the past year. The answer to that repeated question—"Did it feel like church?"—was not the same for every person, for every practice, for every occurrence. But I can assure you—as your priest and pastor—that we worshipped God this year: sometimes awkwardly, sometimes unevenly, always faithfully and joyfully.

Communication: Without the familiar opportunity for word-of-mouth communication that in-person worship (and coffee hour!) offers, we turned to other methods to communicate, and increased our use of them. The skills, enthusiasm, hard work, and focus of our administrative associate, Amber Barsaleau, were absolutely central to this. There are thousand things I could thank Amber for, but for now, I want to highlight the ways her creation and support of our communications literally helped keep this faith community together. Amber edits and publishes at least 5 e-newsletters each week. She edits, prints, and mails our monthly paper newsletter, and gives administrative support to our Fath@Home mailings. She supports our worship, too: creating the slides that bring the words of our on-line worship to our eyes, and by being our zoom meeting manager, which allows those leading worship to simply do that, and not have to keep an eye on the tech as well.

In another communications/worship overlap, Music Director Ash Morgan (and family) brought our video communications up several levels, with their production of remarkable and moving Advent and Christmas videos. Thank you all for that, and to Ash, for adapting his music to the challenges of on-line worship.

Communication also characterized your links with each other. Cards, letters, phone calls, emails, texts: they draw us together, each to each. Deacon Maryan, Sandy Adams, and Kathy Lennox each nurtured our parish's "official" caring correspondence, alongside each and every way to you connected with your church family, on your own initiative. Thank you.

Leadership: 2020 was our first full year as a bi-vocational congregation, where initiative, leadership, and service is by definition widely and deeply shared among lay people and clergy. (This was the first year when my call was fully shared between the School for Ministry and the congregation.) Your Bishop's Committee pivoted to new ways of working together, meeting over zoom, voting (when needed) over email, and even holding one hybrid meeting where some of us met outdoors and others "zoomed in." The vision and grace with which the Bishop's Committee discerned our new name, "Emmanuel," was remarkable. My gratitude to our 2020 officers (Deb, Joan, Paula, Ruth, and Wayne) and Bishop's Committee members is immeasurable. Thank you.

I also want to recognize the leadership demonstrated by the team who shepherded the sale of 263 Highland St., Plymouth. (Details of that process are included elsewhere in this annual report.) I'm deeply grateful to Holderness School Chaplain the Rev. Josh Hill, for nurturing our links with Holderness, and being a tireless advocate for this visionary connection between faithful Episcopalians and our neighboring Episcopal school. The Rev. Sandi Albom's launch of a recovery ministry at PSU, in the role of Episcopal chaplain, was hampered by restrictions on campus life because of the pandemic. Those efforts, as well as her previous work at Plymouth House (the Eucharists there were recorded in our register of services), were a gift to this area. (She now serves as an interim rector in the Diocese of Western Massachusetts.)

And we (and I) are blessed beyond measure by the prayerful and pastoral presence of the Rev. Deacon Maryan Davis among us, a living example of true servant leadership.

As we begin our fourth year together, and our first as Emmanuel Episcopal Church, my prayer is that we live up to and live into that faithful claim: God is with us.

Annual Report of the Faith at Home Formation Program

It's a grand thing to remember that our Faith at Home formation program started off the year 2020 with much excitement as we celebrated the Season of Epiphany with a party held in Sherrill Hall that included prayer, scripture meditation, conversation and the making of crowns. A simple lunch of soup and sandwiches was provided by a group of volunteers and Sunday school teachers led by Jean Murphy. A complete success, however, not to be out done by the traditional Three Kings Cake supplied by Rev. Kelly. Hidden in that cake was the baby Jesus just waiting to be found! And found he was to the surprise of Maya Hill. But the best was yet to come! Each child was presented with an age appropriate NRSV Bible of their very own: beautifully inscribed with their name by our Sr. Warden Ruth Harlow.

It was easy to feel the children's excitement and a gift to know these Lectionary based Bibles would serve as the foundation of our Faith at Home program going forward. And well they did. Even the Covid pandemic that began in March and is still among us couldn't squash the intent for the Faith at Home Program to serve our faith community with the Good News of Jesus Christ. By Easter the whole congregation was invited into the program. Weekly lessons with discussion questions, thoughtful meditation and hands on activities abounded via our weekly newsletters with the huge support of our office administrator, Amber B

FAH packets were delivered to families in June and again in September with thoughtful ideas for hands-on activities that didn't require a trip to the store to buy supplies. The fall also brought about our very own space in Tuesday Topics granting us the privilege to post lessons and projects when direct contact with families became more restricted. Possibilities abounded and Tuesday Topics seemed a fresh new way to offer a blend of different formation opportunities at a time when those offerings were so needed. It was now possible for us to share a link to the Children's Chapel of St. Mathews Episcopal Church, Alto Palo California that offered a very well done series of Biblical story's created by their Minister of Christian Education. Tuesday Topics also became home to our Compline Bedtime Prayers . . . a short service of child friendly prayers formed after the Compline Prayers in our Book of Common Prayer and placed on slides with backgrounds that bring forth the intended message as well as a sense of peace. These lovely prayers are read by Kelly Patten, a fourth grade student in our Sunday School.

It seemed simplicity was the goal with the Advent, Christmas, and Epiphany Seasons fast approaching and our faith community wanting to send out a message of quiet peace that served to provide a gentle presence among us that offered us the courage to forgo the rush and exhaustion that can come upon us so quickly at this time of year and to center ourselves in the gift of waiting to receive the new birth of a Holy Child who was incarnated to live in our hearts. The Holy Child whose mother Mary named Jesus according to the will of God and whose ministry of love, compassion and just ways of living we have by our Baptismal Vows faithfully chosen to follow.

How might each one of us hold that Holy Child so close . . . and the children of Emmanuel Episcopal as well? Junior Warden's Annual Report/Building

All services are being performed as contracted. Dead River is maintaining both fuel and systems. They are in the beginning process of evaluating the current equipment. Mason Brother's have been plowing, sanding, shoveling, and did the summer maintenance. JP Pest services continues to monitor and treat, as needed and contracted. There has been no use of the buildings as rentals since early 2020. The beginning stages of an energy audit have been completed. The auditor began with the sanctuary and conducted an infrared test. Further visits and tests will be conducted. The elevator was tested both for operation and weight. Ned McElroy graciously changed the emergency light. An updated certification is posted.

Report on the sale of 263 Highland Ave, Plymouth

Sale of Church Property 263 Highland Street, Plymouth

Last fall, 2019, the Bishop's Committee authorized the working group of Winnie Hohlt, Wayne Trombly, and Paul Wilson to arrange for and to complete the sale of the land and buildings on Highland Street in Plymouth. The buildings there consisted of the red house (the CLC/ Community Life Center), used as the church office, chapel, meeting room and classroom, as well as Griswold Hall which was used to hold religious services since the previous sale of the Church of the Holy Spirit property on Main Street, Plymouth, in November, 2017. Griswold Hall had also continued to serve as the location for 12-step groups, community groups, church meetings, and church educational and social events.

The working group met to discuss how to proceed: we needed to choose a realtor, agree on an offering price, and to get consent from the Diocese office. The owner of record of all church property is the Bishop of the Diocese of New Hampshire. We chose Roche Realty as the selling agent, since they have a good reputation in Plymouth for sale of commercial properties. The selling price was determined by considering the input from the realtor, the official Plymouth property assessment, and the input from an independent property appraiser. The property was listed for sale in March, 2020, for \$249,000.

Over the summer, several parties expressed interest, and made offers, but none were completed due to unacceptable terms. Finally, a full price offer was made in late July by

a local contractor but, after building inspection, found a number of property deficiencies that needed to be corrected. There was also a requirement that the sale be completed by August 28.

In the meantime, a great deal of church records, furniture, religious articles filled the basement, main floor, and attic of the red building, as well as the main floor and attic of Griswold Hall. Reverend Kelly, as well as Winnie Hohlt, Ruth Harlow, and Deacon Maryan Davis worked tirelessly for weeks categorizing and packing these articles. We arranged for moving these things to the new office on Main Street Plymouth, to the St. Mark's sanctuary and Sherrill Hall, in Ashland; to the Chapel of the Holy Cross at the Holderness School; and to Tilton, for the use of the Diocese's new School for Ministry, which is based there. Thanks are due as well to the church quilting group, who had previously prepared their materials for moving, and to Jean Murphy, whose care with organizing and cleaning at Sherrill Hall eased the move-in. This packing and moving was done under the duress of the strict timeline of vacating the property by August 28, as well as under the health strictures imposed by the pandemic.

What remained to be resolved was the repair of property deficiencies as well as the removal of excess furniture that needed to be completed by the deadline. We are grateful that the Habitat for Humanity Re-Store team was able to pick up furniture we did not need going forward. Unneeded kitchen items were donated to Ladders Thrift Shop, which supports local veterans' services.

Fortunately, the buyer was willing, for a slight reduction in selling price, to waive the requirements of repairs and cleaning of buildings to allow the sale to go forward on time. We coordinated throughout the process with the Bishop's office in Concord to gain agreement and to obtain signatures by the Diocese Office. The work of Wayne Trombly was instrumental in his liaison with that office.
